**VILLAGE OF LAKE IN THE HILLS
PARKS & RECREATION BOARD MEETING
February 4, 2021**

The Parks & Recreation Board meeting was called to order at 6:30 p.m. Those present were Members Wackerlin, Cairns, Anderson, Sivakumar, Andrea, Donahue and Chairwoman Tredore. Also present were Recreation Superintendent Kim Buscemi, Public Properties Superintendent Scott Parchutz, Recreation Supervisor Kristi Brewer, Administrative Services Manager Peter D'Agostino, Public Works Director Tom Migatz, Trustee Murphy and Customer Service Specialist Tracey Padula.

APPROVAL OF MEETING MINUTES

Member Wackerlin made a motion to approve the January 7, 2021 minutes of the Parks & Recreation Board meeting. Member Anderson seconded. The motion was approved by a voice vote of 7-0.

OLD BUSINESS - None

NEW BUSINESS – Chairwoman Tredore indicated that review would start with B instead of A.

B. Request for Board Action 2021 Playground and Skate Park Replacement - Manager D'Agostino explained that the 2021 village budget contained funds for replacement of the existing skate park at Sunset Park and the existing playground equipment at the Ford School Park. He highlighted the process that was followed in getting the potential concepts from the vendors and also mentioned greater detail could be found in the executive summary contained in the packet. Two resident surveys were administered to gather input. The first was looking for resident input on features while the second asked residents to rank the design concepts that were submitted. There were seven potential concepts for the skate park and nine potential concepts for the playground. After review, discussion and questions on various topics such as materials and space, color was one topic the board wanted to have a say in the final outcome. Manager D'Agostino said that would be possible and then each member was asked to rank their top three concepts on each project. After tallying the votes, the top three for each project were Concepts 4, 1 and 2 for the skate park at Sunset Park and Concepts 2, 3 and 4 for playground at Ford School Park. He explained the next step would be to invite those vendors to participate in the Request for Proposal process which would then be a more detailed, all-inclusive proposal with pricing. This also gives those vendors one last opportunity to adjust their concepts. Review of the submitted Request for Proposals would be done by Manager D'Agostino at the March 4, 2021 Parks and Recreation Meeting. The Parks and Recreation Board would then need to recommend one proposal for each project for review to the Village Board at the March 23, 2021 Committee of the Whole meeting.

A. Request for Board Action Parks and Recreation Agenda Timeline - Superintendent Buscemi shared a timeline that was developed by the staff consisting of agenda items that need to be addressed yearly by the Parks and Recreation Board. This will ensure the items are done in a timely manner and done at the appropriate time during the year. At the beginning of each year a review will be done to add or change items with the understanding that new items will likely be added as they come up. It was then opened up to questions and additions. It was suggested to add Larsen Park to the timeline, which would enable advanced planning. The board would like this to be a premier park similar to Sunset Park. Superintendent Buscemi agreed this topic can be added for monthly review and then shared that the 2021 Village Budget allowed for an architect to be hired who will help with the entire process of developing the Master Plan. Any prior input already given by the board would be shared with that architect. The goal will be to have the architect

hired and the process of the master plan which would include general information, phases and a high level cost amount, prior to the end of this year. All of this would then be shared with the Village Board. Superintendent Buscemi did have one item which was the NISRA membership fee review that needed to be changed to October and the timeline will be updated to reflect that.

C. Informational Memorandum Pickleball – After the Parks and Recreation Board requested more information on creating pickleball courts, Superintendent Parchutz reviewed two options. First option would be to repurpose two of the four existing tennis courts at Sunset Park or Leroy Guy Park with the work being done in-house for a cost of \$3,000. The second option was to create a new pair of pickleball courts somewhere within the village for an approximate cost of \$71,903. After review and discussion on both options the board felt it would be more cost efficient to re-purpose existing courts and also recommended doing a single court at each of the parks to see how the public liked them. A motion to recommend the first option was made by Member Anderson. Chairwoman Tredore seconded. The motion was approved by a voice vote of 7-0.

D. Request for Board Action Village Skating Rinks – Superintendent Parchutz reviewed information on prior year's ice skating rinks that had been located at Sunset and Stoneybrook Parks and explained the challenges they experienced in keeping them functional throughout the season. This was in response to the board's request to keep this topic open for consideration next year after not having any skating rinks this year. Staff proposes to relocate the two rinks to Indian Trail Beach next season, which would run on or about December 15, 2021 and close on February 28, 2022 depending on ice thickness. The rink would be located within 70 feet of the beach which is four feet deep. The area would be marked off so users would know the safe zone. Staff would check ice thickness regularly and use a flag system similar to what is used during beach season. Green would mean ice is safe and open and red would mean ice is not safe and the rink is closed. Hours would be dawn to dusk so lights would not disrupt residents. The board felt this was a great suggestion and a motion to recommend relocating the ice rink to Indian Trail Beach for next season was made by Member Andrea. Member Cairns seconded. The motion was approved by a voice vote of 7-0. The board felt some sort of a boundary wall would be needed for safety plus it visually would make residents feel more comfortable. Superintendent Parchutz said staff would look into it along with additional signage.

E. Informational Memorandum Parks Project Update 2021 – In response to the board's request to providing an ongoing parks project report showing costs, Superintendent Parchutz presented the status report and asked if there were any questions. Member Anderson asked if this could be converted into a spreadsheet that could be easily reviewed monthly to show total cost, overall yearly budget and where each projects falls plus or minus.

STAFF REPORTS

Recreation Staff Report: Superintendent Buscemi highlighted the upcoming events. February 1- through 28 at Leroy Guy Park is the Winter Story Walk. Sweet Barks Social on February 13 was cancelled due to the upcoming weather forecast putting the safety of the pets and owners first. The Daddy Daughter Date is February 20. Volunteers are still needed for this event and to email Superintendent Buscemi if interested. A thank you to Member Anderson for helping the staff out with the Winter Wonderland and also to her and Trustee Murphy for helping out with the Ice Fishing tournament. Now that the county is in Phase 4 youth sport classes have started up again along with karate, yoga and early childhood classes. She also thanked the board for providing the feedback on disc golf and cornhole. Communications division has put out social media posts about disc golf to help familiarize the residents and the recreation staff has added a cornhole event to the brochure for spring.

TRUSTEE LIAISON REPORT - Nothing from the board but Trustee Murphy did want to say what a great job staff did on the Ice Fishing Tournament. She was there and commented that being there in person gave her the opportunity to see how much everyone enjoyed it.

- F. Member Sivakumar - Just wanted to confirm the top 3 concepts picked by the board for the skate park. Manager D'Agostino confirmed 4,1 and 2.
- G. Member Wackerlin - Went out and familiarized himself with the Disc Golf course since the Cub Scouts now have a new badge for this. He is putting together a list of Scoutmasters names so a letter or outline can be sent to each of them.

AUDIENCE PARTICIPATION – Jake Daigle lives near Cattail Park and enjoys going there with his friends. He pointed out that right now there are only things for smaller children and wanted to know if a basketball court could be put in for kids his age. There is a large field to the North of the playground that would be a great location. Nothing large and expensive just a basic court. Member Wackerlin asked if they would want a full court with hoops at each end or if a half court would work. Mr. Daigle commented anything would be great. Director Migatz was prepared with a response on the cost for this request. A half court, asphalt with one hoop was \$28,000 and this is something that is not in the budget at this time but is something that can be looked at during the capital budget process. Projects of this size are projected out 5 years. Chairwoman Tredore asked if this is something that could be done in house and Director Migatz said no. The only cost that could possibly be brought down would be to have staff install the hoop. The biggest part of the cost is the asphalt. Member Andrea asked if there were any parking lot replacements coming up in the parks that this could be added on to save money. He also suggested looking into some volunteer days. Director Migatz thought that was a great suggestion and would look into as a possible community project.

ADJOURNMENT

Member Andrea made a motion to adjourn the meeting. Member Anderson seconded the motion. The motion was approved by a voice vote of 7-0. The meeting adjourned at 7:23 pm.

SUBJECT: 2021 Playground and Skate Park Replacement Project

EXECUTIVE SUMMARY

This year, the Village plans to replace all the existing skating equipment at Sunset Park, as well as all the existing playground equipment (including the swings) at Ford School Park. After the Board approved the FY2021 budget last December, staff began to gather feedback from residents through an online survey on potential features to consider including in the subject locations. Staff included the survey results in the Request for Simplified Proposals (RFSP) released to vendors in January. Through the RFSP process, the Village received nine design concepts for the Ford School Park Playground and seven design concepts for the Sunset Park Skate Park. After receiving the RFSP design concepts, Staff released a separate survey for each location asking residents to rank each design concept plan in order of preference. The results from these two surveys were provided to the Parks and Recreation Board members, before their February 4th meeting.

February 4th Parks and Recreation Board Meeting

At its February 4th meeting, the Parks and Recreation Board met and used public input to narrow down the RFSP design concepts and select three design concepts for each location. Following this meeting, the vendors that submitted the three selected design concepts for each location were asked to participate in a Request For Proposal (RFP) process that requested pricing and a final design concept.

Request For Proposal (RFP)

The Request For Proposal (RFP) opening occurred on February 19th and the RFP bid tabulation and copies of the final design concepts are included in this report. Although three skate park design vendors were selected to participate in the Sunset Skate Park RFP, one vendor decided not to continue to participate in this process. After receiving the final design concepts, staff released another round of surveys for each location asking residents to rank each final design concept in order of preference. Staff will provide the results from these two new surveys to Parks and Recreation Board members before their March 4th meeting.

Next Steps

After reviewing the final design concepts and considering resident feedback obtained through the most recent Village resident survey, staff request that the Parks and Recreation Board select one final design concept for each location for recommendation to the Village Board of Trustees at their March 23rd Committee of the Whole Meeting.

Park Feature Friday Campaign Report

Prepared for the Parks and Recreation Board

Objective

The Village communications team launched the “Park Feature Friday” campaign in September 2020. The series educates area residents about the many Lake in the Hills parks and facilities that the Village maintains. The campaign offers the Public Properties Division social media exposure, particularly when park features coincide with news on equipment replacements, and contributes to the Recreation Division’s efforts to promote equity within the community as parks are free for all to enjoy.

Description

The campaign features posts across the Village Facebook, Instagram, and Twitter channels and utilizes the hashtag #ParkFeatureFriday. Posts and stories describe the amenities at the featured location and highlight key moments in the park’s history. Facebook and Instagram stories complement the posts by harnessing another outlet for visual storytelling. While the posts feature recent photos of the locations, the stories show both current and past photos of the parks to show followers how the Village has developed and improved the locations over the years.

Current Features

As of February 1, 2021, five Village parks have been featured:

- Leroy Guy Park (September 4, 2020)
- Echo Park (September 25, 2020)
- Horner Park (October 9, 2020)
- Linda K. Fischer Park (October 16, 2020)
- Sunset Park (January 15, 2021)





Analytics Overview

- 15 posts shared across the Facebook, Twitter, and Instagram profiles
- 31 individual story “slides” shared to Facebook and Instagram stories
- 12,589 total **impressions** (number of users that saw a post) between stories and posts
 - 9,845 impressions from posts
 - 2,744 impressions from Facebook and Instagram stories
 - Average of 703 impressions per post
 - Average of 91 impressions per story “slide”
- 7% average **engagement rate** (percent of users who interacted with a post) per post
 - 18.4% highest engagement rate (Facebook Post)
 - 2.5% lowest engagement rate (Twitter Post)

Observations

Facebook Performance

Of all the Facebook posts, the Leroy Guy Park post gained the most impressions (1,496). The Sunset Park feature saw the fewest impressions (1,260) and lowest engagement rate (7%). The lower interest levels may be related to the colder weather and snow.

Playground and Skate Park Replacements Increase Engagement

When “Park Feature Friday” posts announced the reopening of the Horner Park and Echo Park Playground after the playground equipment was replaced, Facebook engagement rates rose higher than those of the other park features. The Horner Park Facebook post reached an 18.4% engagement rate, the highest rate of all the Facebook posts, and gained 1,469 impressions. The Echo Park feature saw an engagement rate of 14.6%, the second highest rate of the posts, and gained 1,293 impressions.

Instagram Performance

Multi-photo carousel Instagram posts gained more impressions than single-photo posts, though the trend did not apply to engagement rates. The Linda K. Fischer Park photo carousel post gained the most impressions (341) and the Horner Park single-photo post gained the least impressions (231). The Leroy Guy Park single-photo post saw the highest engagement rate (8.5%) and the Sunset Park carousel post saw the lowest (3.1%).

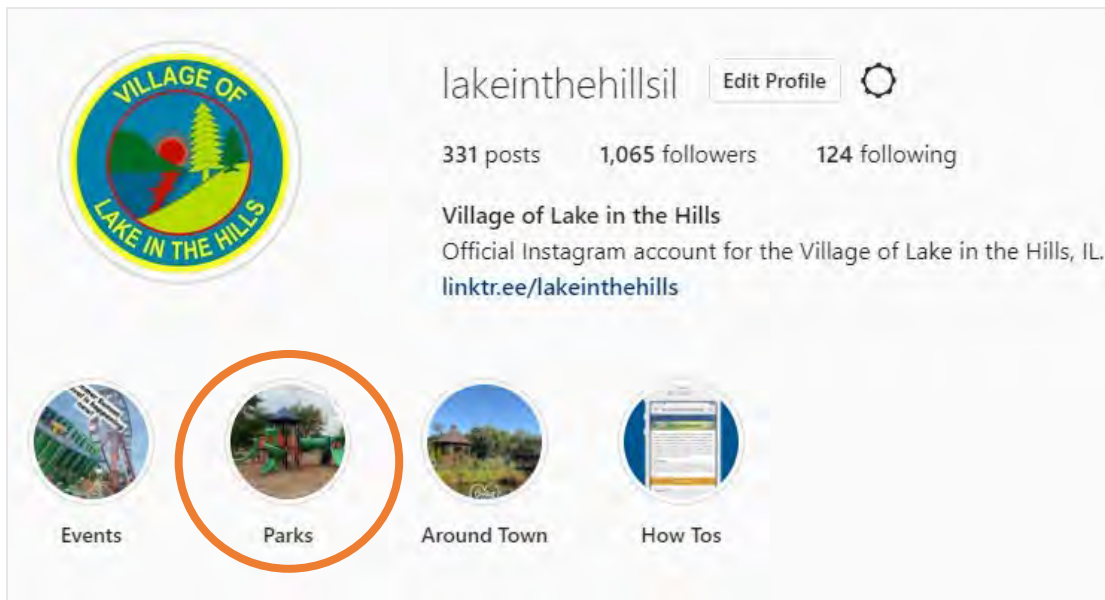
Twitter Performance

The Linda K. Fischer Park tweet gained the most impressions (488) and highest engagement rate (7.6%). The Sunset Park tweet saw the fewest impressions (236) and the Echo Park tweet saw the lowest engagement rate (2.5%).

Future Development

Future posts and stories will contribute to the current goals established for the series. Posts will feature the 2021 replacement projects at Ford School Park and Sunset Skate Park once complete. Communications will continue to share both information on amenities and interesting facts about Village history.

Though stories expire after 24 hours, the “Park Feature Friday” stories will continue to be displayed on the Village Instagram page as a highlight. The stories can be accessed through the “Parks” highlight, shown below. The easily accessible stories promote the Village’s parks and green space as attractions for residents, prospective residents, and visitors after their initial lifespan.

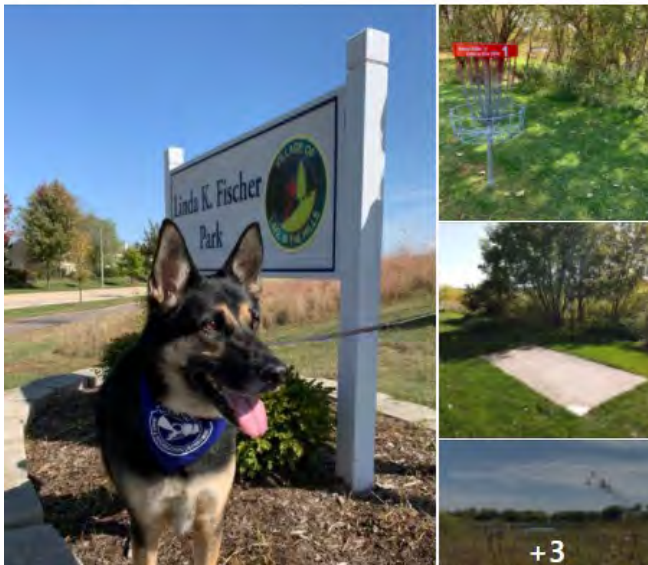



***February Programming:** Moving into phase 4 of the pandemic allowed for larger, in-person activities. Once again, staff and contractors adapted to the changes and quickly opened up in-person programs. Some program sessions were re-designed to allow for a later start. Virtual programming does not seem to be a popular choice for the community. Staff continue to be creative with logistics for in-person programming, allowing as many participants safely as possible. A great example of this, is the Daddy Daughter Date event. Please refer to the details in Casie Peltz's report.

*** Spring Brochure:** This is the first brochure to be offered only on the Village's website and not delivered to homes. A large postcard was mailed to all residents promoting the spring brochure. Call-outs were made in the winter brochure announcing the change. Other avenues such as social media posts, Resident Insider, Community Pass e-blasts, and flyers are being used to promote the brochure.

*** Leadership Greater McHenry County (LGMC) presentation:** LGMC is a network of business leaders and community influencers, that come together to gain an understanding of issues McHenry County is facing and learn to lead more effectively. Kim Buscemi, Recreation Superintendent, was invited to present a segment on health and fitness opportunities for youth/young adults in the county. This is a great opportunity to share with the class how essential recreation departments are to the community. As part of the day, a group will be completing an exercise in which they must visit Village Hall and learn what recreation programs, services, and facilities are available for the youth/young adults.

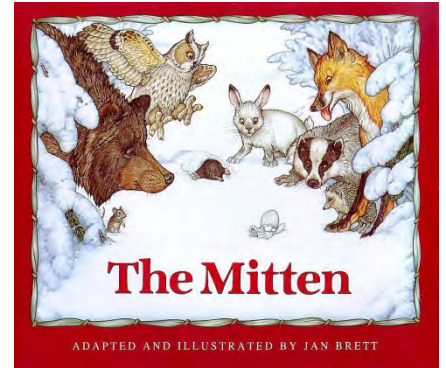

*** Preschool Academy:** Remote Preschool Academy session two will end in March with 31 students (Session one 33 students). Session three will include a hybrid model, which provides for one-day of in-person instruction, and the remaining class days are conducted virtually. Session three takes place from April 5 through May 28.

2021/2022 Preschool Academy registration is open to those students and families who have participated in the 2020/2021 season through February 28; new resident enrollment begins March 1, followed by open registration on March 8. Current plans include a full in-person program starting in September 2021 with modifications dictated by state and local health department guidelines.

*** Ready, Set, Go: Early Childhood Socialization:** Session two concluded in February with six enrolled (Session one enrollment was 6), and offered outer space-themed indoor and outdoor activities. Dr. Seuss activities are planned for session three that begins in March.

* **StoryWalk® at Leroy Guy Park:** A free StoryWalk® was installed on the path at Leroy Guy Park. February's walk featured *The Mitten* by Jan Brett. Each panel tells part of the story with an activity or question to encourage children's imagination, critical thinking, and family discussion. The Village and the StoryWalk® Project seeks to promote early literacy, healthy physical activity, and family time together in nature. The StoryWalk® for March 1 through March 31 takes place at Village Hall and features the book *Cat's Colors* by Airlie Anderson.



* **Versiti Blood Drive:** A Versiti mobile blood drive at Village Hall hosted 18 donors on February 23. The Recreation Division has scheduled multiple drives for 2021. The Village Hall location has been a critical donation site for donors. The next blood drive is scheduled for June 3.

* **Illinois Parks and Recreation Association Virtual Roundtable:** Kristi Brewer, Recreation Supervisor, attended multiple virtual roundtable discussions with the teen, early childhood, aquatics, day camp, and school-age IPRA committee meetings in February. The virtual discussions allowed for an improved understanding of what programming might look like for summer provided the ability to share ideas with other professionals and discuss trending topics within the recreation industry.

* **Special Events:** The Recreation staff hosted the annual **Ice Fishing Tournament** on Saturday, January 30th at Indian Trail Beach from 8:00 a.m. to 11:30 a.m., and the winners were recognized at an award ceremony at 11:30 a.m. via Facebook Live. *** UFO – Unfinished Craft Objects:** Adults/Seniors will be able to resume in-person meeting starting February 27, from 8 am – 4 pm.

The conversation resulted in the selection of three preferred designs for inclusion in the Request for Proposal (RFP) process. The RFP opening occurred on February 19 and the Board will review copies of the RFP bid tabulation and copies of the final design concepts at its meeting on March 4th.
- Sunset Skate Park Equipment
 - The Parks Board selected four skate park design vendors to participate in the RFP process. Days before the final submittals were due, one of the vendors dropped out of consideration leaving three to offer proposals. A final survey is out in front of the public to determine their most desired design from the RFPs Staff will provide the results from this latest survey to the Parks and Recreation Board members before their March 4 meeting. After reviewing the final design concepts and considering resident feedback obtained through the most recent Village resident survey, staff requests that the Parks and Recreation Board select one final design concept for recommendation to the Village Board of Trustees at their March 23 Committee of the Whole Meeting.
- Hain House Renovation and Repair Project
 - This initiative includes replacement of the water heater and dehumidifier and the installation of a basement heater and sump pump. Staff began the process of acquiring the equipment needed for the upgrade project by purchasing the on-demand water heater. Staff bought the water heater on clearance for under \$400 which is a significant savings since the heater typically lists for \$1500.
 - Additional work will include:
 - repairing foundation cracks and;
 - re-piping of exiting water lines as the current pipes do not provide adequate pressure

- Bark Park Gate replacement and Software Upgrades
 - Entrance Systems provided onsite training to Public Works and Village Hall staff on its user-friendly software. This early training will allow for a smooth transition when the construction upgrades and full implementation are rolled out later this year.
 - Installation of the gates and associated hardware is weather-dependent with work expected to begin in the spring.

- Sunset Fields 4, 5, 6, and 7 - Erosion Mitigation
 - This project will reduce infield runoff during rain events and eliminate three fields in favor of one high-end field similar to Plote Field. Renovation is on hold until the ground recovers from winter and conditions are conducive to construction efforts.

- Ford School Classroom – HVAC Upgrade
 - Nicor will install the new gas line in March. Staff will purchase a new furnace with an air conditioning unit to eliminate humidity thereby preventing mold and mildew.
