

APPENDIX A

Lake in the Hills Municipal Code Definitions

Abandoned Vehicle: Any vehicle in a state of disrepair rendering the vehicle incapable of being driven in its condition; or any vehicle that has not been moved or used for seven consecutive days or more and is apparently deserted.

Accessory Structure: A building, the use of which is incidental to that of the principal building and which is located on the same lot.

Administrator: The chief administrative officer of the Village.

Agreement: Pursuant to Chapter 13, the current agreement between the Village and Village Hauler that has been authorized by the Board of Trustees.

Air Rifle: Includes any air gun, air pistol, spring gun, spring pistol, BB gun, pellet gun or any implement that is not a firearm which impels a projectile constructed of hard plastic, steel, lead, brass or any other hard material with a force that is reasonably expected to cause bodily harm or property damage.

Alcohol: The product of distillation of any fermented liquid, whether rectified or diluted, whatever may be the origin thereof, and includes synthetic ethyl alcohol. It does not include denatured alcohol or wood alcohol.

Alcoholic Liquor: Alcoholic liquor includes alcohol, spirits, wine and beer, and every liquor or solid, patented or not, containing alcohol, spirits, wine or beer, and capable of being consumed as a beverage by a human being.

Antique Vehicle: Any motor vehicle or other vehicle 24 years of age or older.

Appliances: Including but not limited to ranges, refrigerators, dishwashers, washing machines, dryers, room air conditions, freezers and water heaters.

Barrier: Pursuant to applicable Building Codes, a fence, wall, building wall or combination thereof which completely surrounds the swimming pool and obstructs access to the swimming pool.

Basement: A portion of any building located partly underground but having more than half of its clear floor to ceiling height below the average grade of the adjoining ground.

Beer: A beverage obtained by the alcoholic fermentation of an infusion or concoction of barley, or other grain, malt and hops in water, and includes, among other things, beer, ale, stout, lager beer, porter and the like.

Bin: Pursuant to Chapter 13, approved containers as outlined in the Agreement.

Board of Trustees: The Trustees of the Village of Lake in the Hills.

Boat: Any device used or capable of being used for navigation on water.

Bowling Alley: A recreational area or facility contained within a building and so constructed as to permit the public to engage in the recreational form commonly known as bowling and constructed primarily for use in connection with such recreational pursuit.

Building: Any residential or nonresidential support, shelter or enclosure of persons, animals or movable property of any kind, and which is permanently affixed to the land.

Building Commissioner: The Building Commissioner of the Village or his authorized deputy, agent or representative.

Building Drain: That part of the lowest horizontal piping of a drainage system which receives the discharge from soil, waste and other drainage pipes inside the walls of the building and conveys it to the building sewer, beginning five feet outside the inner face of the building wall.

Building Sewer: The extension from the building drain to the public sewer or other place of disposal.

Café: A specialized type of restaurant that is used as an informal gathering place where a variety of non-alcoholic and alcoholic beverages, breakfast food, appetizers, and sandwiches are prepared, served, and sold. The non-alcoholic beverages and food offerings shall make up at least 50% of the total gross revenue from all food and beverage on an annual basis. The total gross revenue from all food and beverage shall include alcoholic beverages, non-alcoholic beverages, and food. The determination

of whether the 50% standard has been met shall be made at the time of license renewal for the year just ended, or, in the event that a licensee has not possessed a class A-2 license for a full year the determination of whether the 50% standard has been met shall be deferred until the next license renewal period. The records used to determine whether said 50% standard has been met shall include, but not be limited to, audited financial statements, corporate financial reports, tax return information, state liquor license reports, or any other form of information deemed acceptable by the Village.

Charitable Organization: An organization or institution organized and operated to benefit an indefinite number of the public. The service rendered to those eligible for benefits must also confer some benefits upon the public.

Clerk: The Village Clerk of the Village of Lake in the Hills.

Club: For purposes of Chapter 33 of this Code, a corporation organized under the laws of this State, not for pecuniary profit, solely for the promotion of some common object other than the sale or consumption of alcoholic liquors, kept, used and maintained by its members through the payment of annual dues, and owning, hiring or leasing a building or space in a building, of such extent and character as may be suitable and adequate for the reasonable and comfortable use and accommodation of its members and their guests and provided with suitable and adequate kitchen and dining room space and equipment and maintaining a sufficient number of servants and employees for cooking, preparing and serving food and meals for its members and their guests; provided, that such club files with the Local Liquor Control Commissioner at the time of its application for a license pursuant to Chapter 33 two copies of a list of names and residences of its members, and similarly files within 10 days of the election of any additional member his or her name and address; and, provided further, that its affairs and management are conducted by a board of directors, executive committee or similar body chosen by the members at their annual meeting and that no member or any officer, agent or employee of the club is paid, or directly or indirectly receives, in the form of salary or other compensation any profits from the distribution or sale of alcoholic liquor to the club or the members of the club or its guests introduced by members beyond the amount of such salary as may be fixed or voted at any annual meeting by the members or by its board of directors or other government body out of the general revenue of the club.

Collector: The duly appointed Village Collector. In the event a Collector has not been appointed, then that person (s) designated for collecting fees, payments, etc.

Combined Sewer: A sewer receiving both surface runoff and sewage.

Combustible Waste: All waste substances capable of incineration or burning, but excluding explosive or highly flammable material.

Construction: Any site preparation, assembly, erection, substantial repair, alteration or similar action, but excluding demolition.

Construction Vehicle: Any vehicle used in, and that is hauling, picking up or delivering materials, equipment and related apparatus then being used in the construction, remodeling, repair, replacement, enlargement or addition of or to any improvement on a lawful site within the corporate limits of the Village for which a permit has been duly issued, and is then outstanding.

Country Club: A recreational area with buildings or structures used in conjunction therewith for the primary use of members and their guests as the case may be, all of which is established for recreational and entertainment purposes and used in conjunction with recreational pursuits or games, e.g. golf, tennis, etc.

County: McHenry County.

Curbside: Pursuant to Chapter 13, off the street and highway pavement and within five feet thereof.

Curfew: A prohibition against any person or persons walking, running, loitering, standing or motoring upon any alley, street, highway, public property or vacant premises within the corporate limits of the Village, except officials of any governmental unit and persons officially designated to duty in a civil emergency.

Demolition: Any dismantling, intentional destruction or removal of structures, utilities, public or private right-of-way surfaces or similar property.

Deputy Clerk: The duly appointed Deputy Clerk of the Village.

Dwelling Unit: A single unit of residence which provides a kitchen or food preparation area, in addition to rooms and spaces for living, bathing and sleeping.

Easement: Land specifically or generally designed for public and/or quasi-public utilities and facilities, only, associated with requirements for sanitary sewer, potable water, storm drainage, gas, electric, telephone, cable television, service, ingress and egress, and service.

Electronic or Mechanical Amusement Device: The term "electronic amusement device" or "mechanical amusement device" is defined as follows:

1. Any machine which, upon the insertion of a coin, trade-token, or slug, operates or may be operated as a game or contest of skill or amusement of any kind or description, and which contains no automatic payoff device for the return of money or trade-token or slugs, or which makes no provision whatever for the return of money to the player.
2. Any machine, apparatus, or contrivance which is used or which may be used as a game of skill and amusement wherein or whereby the player initiates, employs or directs any force generated by the machine.
3. Any machine vending recorded music or a period of radio or television entertainment in return for insertion or deposit therein of a coin, or of trade-tokens or slugs; provided, however, that this does not include coin-operated radios or television sets in private quarters.
4. Any amusement machine and/or electronic device, whether purporting to be games of skill or otherwise, for which a fee or charge is made for the privilege of playing operating the same. *Amended, 1993-94-57*

Employee Organization: Any organization of any kind or any agency or employee representation committee or plan which included in its membership Village employees, and which exists for the purpose, in whole or in part, of dealing with the Village concerning grievances, wages, rates of pay, hours and conditions of employment.

EPA: U.S. Environmental Protection Agency

Firearm: Any device, by whatever name known, which is designed to expel a projectile or projectiles by the action of an explosion, expansion of gas or escape of gas; excluding any pneumatic gun, spring gun or BB gun which expels a single globular projectile not exceeding .18 inch in diameter.

Fireworks: Any rocket, firecracker, torpedo, squib or other similar projectile, or anything containing any substance of an explosive nature, including but not limited to gun powder, gun cotton, giant powder, dynamite, nitroglycerine, fulminate of mercury or other explosives of a similar nature for blasting or other purposes. In addition, the definition for "fireworks" found in 425 ILCS 35/1, as amended, is incorporated into this Ordinance.

Garage Sale: For purposes of Section 31.01 of this Code, garage sales shall mean and include all sales entitled "garage sale", "lawn sale", "attic sale", "rummage sale", "flea market", or any similar casual sale of tangible personal property which is advertised by any means whereby the public at large is or can be made aware of said sale.

Garbage: Any rejected or waste household food, offal, swill or carrion, and every accumulation of animal, fruit or vegetable matter that attends the preparation, use, cooking and dealing in, or storage of meats, fish, fowl, fruits or vegetable, and any other matter of any nature which are subject to decay, putrefaction and the generation of noxious or offensive gases or odor, or, which during or after decay, may serve as breeding or feeding material for flies or other germ-carrying insects.

Goods: Goods are meant to include any goods, warehouse merchandise or other property capable of being the object of a sale regulated in this Code.

Gross Receipts: Pursuant to Chapter 34, the consideration received for the transmission of messages, or distributing, supplying, furnishing or selling gas, or electricity for use or consumption and not for resale, as the case may be; and for all services rendered in connection therewith valued in money, whether received in money or otherwise, including cash, credit, services and property of every kind and material and for all services rendered therewith; and shall be determined without any deduction on account of the cost of transmitting said messages without any deduction on account of the cost of the service, product or commodity supplied, the cost of materials used, labor or service cost, or any other expenses whatsoever. Gross Receipts shall not include receipts received from the Village for the sale to said municipality of any of the utility products or services mentioned above. Gross receipts shall not include any charges added to customers' bills pursuant to the provision of Sections 9-221 or 9-222 of the Illinois Public Utilities Act or any other separately stated charge added to customers' bills in respect of any tax or other governmental imposition.

Highway or Street: The entire width between the boundary lines of every way publicly maintained when any part thereof is open to the use of the public or purposes of vehicle travel. Any street or public way within the Village.

Hotel: Every building or other structure kept, used, maintained, advertised and held out to the public to be a place where food is actually served and consumed, and sleeping accommodations are offered for adequate pay to travelers and guests, whether transient, permanent or residential, in which 25 or more rooms are used for sleeping accommodations and dining rooms being conducted in the same building and such building or structure being provided with adequate and sanitary kitchen and dining room equipment and capacity.

Hot Tub: See definition for spa.

IEPA: Illinois Environmental Protection Agency.

Illinois Compiled Statutes (ILCS): The 1995 edition of the Illinois Compiled Statutes and when later editions are published, the latest publication thereof.

Illinois Municipal Code: 65 ILCS 5/1 et seq.

Inground pool: See definition of swimming pool.

Inoperable Motor Vehicle: Any motor vehicle from which, for a period of at least seven days, the engine, wheels or other parts have been removed, or on which the engine, wheels or other parts have been altered, damaged or otherwise so treated that the vehicle is incapable of being driven under its own motor power. The term "inoperable motor vehicle" shall not include a motor vehicle which has been rendered temporarily incapable of being driven under its own power in order to perform ordinary service or repair operations nor to any motor vehicles that are kept within a building when not in use, to historic vehicles over 25 years of age, nor to a motor vehicle on the premises of a place of business engaged in wrecking or junking of motor vehicles, nor to any motor vehicle which has been rendered temporarily incapable of being driven under its own power by authorization of the Chief of Police.

Labor: For purpose of Section 31.02 of this Code, labor means an organization composed of workers organized with the objective of betterment of the conditions of those engaged in such pursuit. Such pursuit and the development of a higher degree of efficiency in their respective occupations.

Leaves: Small twigs attached to the leaves, but shall exclude other vegetable or plant refuse, garbage, agricultural waste, trees, tree trimmings, branches, stumps, brush, weeds, grass, shrubbery and yard trimmings.

Legal Guardian: A person appointed guardian or given custody of a minor by a Circuit Court of the State, but does not include a person appointed guardian or given custody of a minor under the Juvenile Court Act, 705 ILCS 405/1-1, as amended.

Licensee: An organization, person or firm which has been issued a license, such as to operate a raffle.

Local Liquor Control Commissioner: The President of the Village.

Massage or massage therapy: A system of structured palpation or movement of the soft tissue of the body. The system may include, but is not limited to, techniques such as effleurage or stroking and gliding, petrissage or kneading, tapotement or percussion, friction, vibration, compression, and stretching activities as they pertain to massage therapy. These techniques may be applied by a licensed massage therapist with or without the aid of lubricants, salt or herbal preparations, hydromassage, thermal massage, or a massage device that mimics or enhances the actions possible by human hands. The purpose of the practice of massage is to enhance the general health and well-being of the mind and body of the recipient. "Massage" does not include the diagnosis of a specific pathology. "Massage" does not include those acts of physical therapy or therapeutic or corrective measures that are outside the scope of massage therapy practice.

Massage establishment: Any establishment having its place of business where any person, firm, association, or corporation engages in, carries on, or permits to be engaged or carried on any of the activities referenced in the definition of massage in Appendix A.

Massage services: The performance of a massage.

Massage therapist: Any person who is licensed by the Illinois Department of Professional Regulation and administers massage for compensation.

May: May is permissive.

Minor: A person who is above the age of 11 years but not yet 18 years of age.

Motor Vehicle: Every vehicle which is self-propelled and every vehicle which is propelled by electric power obtained from overhead trolley wires, but not operated upon rails, except for vehicles moved solely by human power, motorized wheelchairs, low-speed electric bicycles, and low-speed gas bicycles. For this Act, motor vehicles are divided into two divisions:

First Division: Those motor vehicles which are designed for the carrying of not more than 10 persons.

Second Division: Those motor vehicles which are designed for carrying more than 10 persons, those motor vehicles designed or used for living quarters, those motor vehicles which are designed for pulling or carrying freight, cargo or implements of husbandry, and those motor vehicles of the First Division remodeled for use and used as motor vehicles of the Second Division.

Motorcycle: Every motor vehicle having a seat or saddle for the use of the rider and designed to travel on not more than 3 wheels in contact with the ground, but excluding a tractor.

Municipality: The Village of Lake in the Hills.

Must: Must is mandatory.

Natural Outlet: Any outlet into a watercourse, pond, ditch, lake or other body of surface or ground water.

Net Proceeds: The gross receipts from the conduct of raffles, less sums expended for prizes, local license fees and other reasonable operating expenses incurred as a result of operating a raffle.

Noise: Any sound which annoys or disturbs humans or which causes or tends to cause an adverse psychological or physiological effect on humans.

Noise Disturbance: Any sound which endangers or injures the safety or health of humans or animals, or annoys or disturbs a reasonable person of normal sensitivities, or endangers or injures personal or real property.

Noise Sensitive Zone: Any area designated pursuant to this Ordinance for the purpose of ensuring exceptional quiet.

Noncombustible Waste: All other waste substance not capable of incineration or burning, including ashes, glass, metal, earthenware and the like.

Non-Profit: Organized, operated and conducted on a not-for-profit basis with no personal profit inuring to anyone as a result of such operation.

Occupant: Any person, over one year of age, living in, sleeping in or having actual possession of a building or portion thereof.

Open Burning: The burning of any materials or substances outside of the confines of the dwelling or buildings located on the premises.

Operator: Any person having charge, care, management or control of any building or part thereof.

Owner: Any person who alone or jointly or severally with others shall have legal or equitable title to any building, the agent of said person or any person having management or control of the building or portion thereof, including, but not limited to a purchaser, mortgagee, receiver or lessee in possession of any building or portion thereof. With respect to Chapter 45 of this Code, any person having a legal or equitable interest in the premises.

Parade: Any parade, march, ceremony, show, exhibition, pageant or procession of any kind, or any similar display, in or upon any street, park or other public place in the Village.

Park or parking: For purposes of Chapter 41 of this Code, the standing of a vehicle, whether occupied or not, otherwise than when temporarily and actually engaged in loading and unloading merchandise or passengers.

Peddling: The selling, bartering or exchanging or the offering for sale, barter or exchange of any tangible personal property upon or along the streets, highways or public places of the Village of from house to house, whether at one place or from place to place, from any wagon, truck, pushcart or other vehicle or from movable receptacles of any kind, but shall not include the delivery of any item previously ordered or the sale of items along delivery routes where the purchaser has previously requested the seller to stop and exhibit his items. Nor shall peddle be taken to include the solicitation of orders by sample where the goods are not delivered at the time the order is taken.

Person: Any natural individual, firm, partnership, trust, estate, club, association, not-for-profit organization, society, taxing body or corporation. As applied to partnerships or associations the word includes the partners or members thereof; as applied to corporations it includes the officers, agents or employees thereof who are responsible for the act referred to. The singular includes the plural, and the plural includes the singular. The masculine gender includes the feminine and neuter genders.

Pier: Any structure or platform built out over the water and supported by pillars or piles, used as a landing place, as during loading or unloading, including any water landing places, and docks.

Plumbing: Gas pipes, gas burning equipment, water heating equipment, water pipes, garbage disposal units, waste pipes, water closets, sinks, installed dishwaters, lavatories, bathtubs, shower baths, installed clothes washing machines, wells, septic tanks, catch basins, drains, vents and any similar supplied fixtures, together with all connections to water, sewer or gas lines.

Population: The population determined by the most recent official Federal, State or Village census.

Powered Model Vehicle: Any self-propelled airborne, waterborne or landborne plane, vessel or vehicle, which is not designed to carry persons, including, but not limited to, any model airplane, boat, car or rocket.

Premises: Any or part of a lot, plot or parcel or tract of land, including the buildings and structures, or part of a building or structure, thereon.

Property: Any real property within the Village which is not a street or highway.

Public Employee or Employee: Any individual employed by the Village but shall not include elected officials, members of boards, authorities and commissions, management employees who are involved directly in the determination of policy or who responsibly directed implementation thereof, supervisors, or any employee who acts as a representative of the Village and any employee who, in the interest of the Village has access to confidential collective bargaining information or who, is a confidential employee.

Public Right-Of-Way: Any street, avenue, boulevard, highway, sidewalk or alley or similar place which is owned or controlled by a government entity.

Public Sewer: A sewer in which all owners of abutting properties have equal rights, and is controlled by public authority.

Public Space: Any real property or structures thereon which are owned or controlled by a government entity.

Public Utility: Any corporation, company, association, joint stock company or association, firm, partnership or individual, their lessees, trustees or receivers appointed by any court whatsoever that owns, controls, operates or manages, with the State of Illinois, directly or indirectly, for public use, any plant, equipment or property used or to be used for or in connection with, or owns or controls any franchise, license, permit or right to engage in:

1. The transmission of telegraph or telephone messages between points within the State of Illinois;
2. The production, storage, transmission, sale, delivery or furnishing of heat, cold, light, power, electricity or water;
3. The conveyance of oil or gas by pipeline; and
4. The disposal of sewerage.

Public Works: The Public Works Department of the Village.

Raffle: A form of lottery, as defined in Section 5/28-2(b) of the "Criminal Code of 1961" (720 ILCS 5/28-2) conducted by an organization licensed under Section 31.02 of this Code in which:

1. The player pays or agrees to pay something of value for a chance represented and differentiated by a number or by a combination of numbers or by some other means, one or more of which chances is to be designated the winning chance;
2. The winning chance is to be determined through a drawing or by some other method based on an element of chance by an act or set of acts on the part of persons conducting or connected with the lottery, except that the winning chance shall not be determined by the outcome of a publicly exhibited sporting contest.

Real Property Boundary: A line along the ground surface, and its vertical extension, which separates the real property owned by one person from that owned by another person, but not including intrabuilding real property divisions.

Recreation Vehicle: A vehicular, portable structure built on a chassis, designed to be used as a temporary dwelling for travel, recreational and vacation uses and/or vehicles with "RV" license plates. A recreation vehicle shall include, but not be limited to, the following: travel trailer, pick-up camper, motorized home and camping trailer.

Refuse: All household garbage, rubbish and kitchen wastes such as discarded food or food residues and paper used for wrapping the same, books, boxes, furniture and other large household items.

Religious Organization: Any church, congregation, society or organization founded for the purpose of religious worship.

Resident: Any person currently maintaining a home within the municipal boundaries whether by property ownership, rental, or tenancy with others. This residency must be with the intent of making this location their home for an extended period of time and cannot be transitory.

Residence: Every separate living unit occupied for residential purposes by one or more persons, contained within any type of building or structure.

Residential: That which is situated on the premises of a detached single or a one-family townhouse, not more than three stories in height.

Residential Area: An area designated for any residential use under the Zoning Ordinance of the Village.

Restaurant: Any public place kept, used and maintained, advertised and held out to the public as a place where meals actually are served and regularly served, without sleeping accommodations, such space being provided with adequate and sanitary kitchen and dining room equipment and capacity and having employed therein a sufficient number and kind of employees to prepare, cook and serve suitable food for its guest. Restaurants may provide clearly incidental and accessory indoor entertainment such as live music or stage performances during customary hours of operation and while food is being served, subject to the conditions that the restaurant must remain open to the public during the entertainment, that no minimum

drink purchase or admission charge shall be levied to patrons of such places, and that any fee charged to patrons shall be for goods or services and not for the passive viewing of the entertainment.

Retail Sale: The sale for use or consumption and not for resale.

Sanitary District: The Lake in the Hills Sanitary District, McHenry County, Illinois.

Sanitary District Superintendent: The Superintendent of sewage works of the Lake in the Hills Sanitary District or his authorized deputy, agent or representative.

Sanitary Landfill: A type of operation in which refuse is deposited by plan in a pit or excavation of open land, is compacted by force applied by mechanical equipment and then is covered by a layer of earth, ashes or suitable covering material to a depth of at least two feet.

Sanitary Sewer: A sewer which carries sewage and to which storm, surface and ground waters are not intentionally admitted.

Senior Living Center: A residential housing community that provides independent and/or assisted living quarters for individuals ages 55 and over.

Sewage: A combination of the water carried wastes from business buildings, residences, institutions and industrial establishments, together with such ground, surface and stormwaters as may naturally be present.

Sewage Works: All facilities for collecting, pumping, treating and disposing of sewage.

Shall: Shall is mandatory.

Snowmobile: A self-propelled device designed for travel on snow or ice or natural terrain, steered by skis or runners, and supported in part by skis, belts or cleats.

Soliciting: Any one or more of the following activities:

1. Seeking to obtain orders for the purpose of goods, wares, merchandise, foodstuffs, services of any kind, character or description whatever, for any kind of consideration whatever;
or

2. Seeking to obtain prospective customers for application or purchase of insurance of any type, kind or character; or
3. Seeking to obtain information on the background, occupation, economic status, social status, religious status, political status, attitude, viewpoints, occupants of a residents, telephone numbers, address furnishings, or the like of another person for the purpose of compiling information as raw data or refined data into a document, record book or directory to be sold or to be used wholly or in part for a commercial purpose; or
4. Seeking to obtain gifts for contributions of money, clothing, or any other valuable thing for the support or benefit of any charitable or non-profit association, organization, corporation, or project.

Solicitor: Any person who has obtained a valid license as provided in Section 35 of this Code, and which license is in the possession of the solicitor on his person while engaged in soliciting.

Spa - portable, non-portable, hot tub: A non-permanent structure intended for recreational bathing, in which all controls, water heating and water circulating equipment are an integral part of the product.

State: State of Illinois

Stop: Pursuant to Chapter 13, each dwelling unit shall be considered a "stop" for the purpose of defining the extent of the collection service to be provided, and of determining the amount of materials collected (refuse, compostable yard waste and recyclable material).

Storage: The stationary placement of any mobile home, boat, trailer or recreation vehicle for a continuous period in excess of 48 hours.

Storm Sewer or Storm Drain: A sewer which carries storm and surface waters and drainage, but excludes sewage and polluted industrial wastes.

Street or Highway: The entire width between the boundary lines of every way publicly maintained when any part thereof is open to the use of the public or purposes of vehicle travel.

For purposes of Chapter 41 of this Code, that portion of the roadway or highway that is improved, designed or ordinarily used for vehicular travel, exclusive of the berm or shoulder.

Strike: Any concerted action in failing to report for duty, the willful absence from one's position, the stoppage of work (including a stoppage by reason of the expiration of a collective bargaining agreement), the interruption or interference with operation of the Village, slow downs or the abstinence in whole or in part from the full, faithful and proper performance of the duties of employment.

Supervisor: Any individual who has authority to recommend hiring, firing, transferring, suspending, promoting and discharging employees; those who have authority to assign employees; and those who direct work, as well as adjust compensation of employees.

Supplied: Paid for, installed, furnished or provided by an under the control of the owner or operator at its own expense.

Swimming Pool: Any structure intended for swimming or recreational bathing that contains water over 24 inches deep. This includes inground, aboveground and onground swimming pools, hot tubs and spas.

This Code: The Lake in the Hills Municipal Code.

Temporary Parking: The stationary placement of any mobile home, boat, trailer or recreation vehicle for a continuous period of less than 48 hours.

Townhouse: A single family dwelling having one or more common wall with another single family dwelling, oriented to all exits open directly to the outside.

Trailer: Every vehicle designed or utilized for the transportation of any boat, auto, snowmobile, motorcycle or other recreational vehicle(s), but is designed to be drawn by another vehicle.

Transmitting Messages: Pursuant to Chapter 34, in addition to the usual and popular meaning of person-to-person communication, shall include the furnishing for a consideration, of services or facilities (whether owned or leased or both) to persons in connection with the transmission of messages where such persons do not, in turn, receive any consideration in connection therewith, but shall not include such furnishing of services or facilities to persons for the transmission of messages to the extent that any

such services or facilities for the transmission of messages are furnished for a consideration by such persons to other persons, for the transmission of messages.

Treasurer: The Village Treasurer of the Village of Lake in the Hills.

Unfair Practice: Any practice prohibited by Section 3.17-F of this Code.

Vehicle: Every vehicle which is self-propelled and every vehicle which is propelled by electric power obtained from overhead trolley wires, but not operated upon rails, except for vehicles moved solely by human power, motorized wheelchairs, low-speed electric bicycles, and low-speed gas bicycles. For this Act, motor vehicles are divided into two divisions:

First Division: Those motor vehicles which are designed for the carrying of not more than 10 persons.

Second Division: Those motor vehicles which are designed for carrying more than 10 persons, those motor vehicles designed or used for living quarters, those motor vehicles which are designed for pulling or carrying freight, cargo or implements of husbandry, and those motor vehicles of the First Division remodeled for use and used as motor vehicles of the Second Division.

Veterans Organization: An Organization or Association comprised of members of which substantially all are individuals who are veterans or spouses, widows or widowers of veterans, the primary purpose of which is to promote the welfare of its members and to provide assistance to the general public in such a way as to confer a public benefit.

Village: Village of Lake in the Hills, Illinois.

Village Board: The President and Board of Trustees of the Village of Lake in the Hills.

Watercourse: A channel in which a flow of water occurs, either continuously or intermittently.

Wine: Any alcoholic beverage obtained by the fermentation of the natural contents of fruits, or vegetables, containing sugar, including such beverages when fortified by the addition of alcohol or spirits, as defined herein.

Zoning Ordinance: The Zoning Ordinance of the Village, as amended.
