### Call to Order

The meeting was called to order at 6:30 pm. Roll Call was answered by Members Wackerlin, Cairns, Sivakumar, Donahue, Carman, Vice-Chairman Andrea, and Chairwoman Tredore.

Also present were, Director of Parks and Recreation Trevor Bosack, Superintendent of Public Properties Parchutz Scott, Administrative Services Manager Peter D'Agostino, Recreation Superintendent Kim Buscemi, Trustee Wendy Anderson, and Recording Secretary Dana Popovich.

## Approval of Meeting Minutes

Motion to accept the Parks and Recreation meeting minutes of June 2, 2022 was made by Member Sivakumar, and seconded by Member Cairns. On a roll call vote, Member Wackerlin, Cairns, Sivakumar, Donahue, Carman, Vice-Chairman Andrea, and Chairwoman Tredore voted Aye. No Nays. Motion carried 7-0.

## Old Business

### A. Lynn Dillow Playground Replacement

Administrative Services Manager of Public Works Peter D'Agostino said that after releasing two rounds of resident surveys, obtaining seven initial design concept plans, and hosting a resident focus group in March of this year, the Parks and Recreation Board at the April meeting narrowed down the seven design concept plans to four. Following that April meeting, staff released the RFP to both companies. There were many complications with the RFP submittals, and because of the many issues the Village Board voted to reject all bids. This allowed staff to work directly with each company to obtain pricing for the four final design concept plans. Staff put together two surveys. Both Surveys asked residents to rank each design in order of preference. One survey was for Village residents, and one was for the focus group.

In reviewing the final four design concept plans, staff would like to draw attention to design three and four. They did not include Pour-In-Place (PIP) surfacing. Staff contacted the company to explore what the added costs would be for Pour-In-Play to be included in the design. The company revised design concepts three and four to add Pour-In-Play surfacing to the slide exits at an additional cost of \$31,360.00 for each design.

Although design concept three received the highest score in the Village resident survey and design concept four received the highest score in the focus group survey, staff does not recommend moving forward with either design. Throughout this process, staff has found the vendors that submitted designs three and four to be challenging to work with both during and after the RFP process. Further, adding Pour-In-Play to designs three and four puts both designs over budget, while failing to create Pour-In-Play paths to playground equipment features.

Staff recommends that the Parks and Recreation Board recommend design concept two to the Village Board, which received the second highest rating from both surveys, while also including the Pour-In-Play paths and other inclusive features. Administrative Services Manager of Public Works Peter D'Agostino opened it up to the Board for any questions.

Member Sivakumar asked about the rope tunnel feature in design concept two. She asked what was the rope made

from.

Administrative Services Manager of Public Works Peter D'Agostino said that information was not in the packet. He asked Superintendent of Public Properties, Scott Parchutz, if he had any concerns with that feature from a Maintenance standpoint.

Superintendent of Public Properties Scott Parchutz said in his opinion, it would be high maintenance.

Member Sivakumar thought it could be easily vandalized, by someone cutting the ropes.

Superintendent of Public Properties Scott Parchutz said if it was vandalized it would be costly to repair.

Recreation Superintendent Kim Buscemi thinks the product would be very durable and the company would stand behind its product if something were to happen.

Superintendent of Public Properties Scott Parchutz said that the manufacturer has to keep the product on the shelf for fifteen years for product repairs.

Member Carman asked what the circle in concept design two was.

Recreation Superintendent Kim Buscemi thinks the circle is where the shelter will go.

Member Carman asked if we could have the vendors of concept two do the design of concept three or four, since the vendors of three and four were difficult to work with.

Administrative Services Manager of Public Works Peter D'Agostino said we work with a design firm which represents the manufacturer and in order to purchase the equipment we would have to use that design firm. They are the people that are difficult to work with.

Chairwoman Tredore said the focus group liked the little caterpillar and butterfly for the younger set. She asked if the designer of concept two could offer a similar feature.

Administrative Services Manager of Public Works Peter D'Agostino said that feature wasn't in concept two, but they did have a section for ages two through five.

Chairwoman Tredore said that the caterpillar or butterfly was the feature the focus group really liked and that is not being offered in concept two.

Member Donahue agreed and added that they liked it for a theme for the park.

Chairwoman Tredore asked if the manufacture was aware that we wanted that feature.

Administrative Services Manager of Public Works Peter D'Agostino said the RFP had a whole list of features from the focus group as well as the survey.

Member Sivakumar asked how popular the sensory wall was with the focus group.

Chairwoman Tredore said it was very popular.

Director of Parks and Recreation Trevor Bosack introduced himself and said that at this point it sounds like the Board would like us to ask the design team of concept two if they could include one or more of those features.

Member Wackerlin said concept two is nice, but it doesn't have a theme to it.

Chairwoman Tredore agreed. She asked if we could go back to the vendor who designed concept two and ask them to prioritize adding one or more features.

Administrative Services Manager of Public Works Peter D'Agostino said that we could go back to the vendors and ask for a revision that would include a frog, caterpillar, or butterfly that would give the park a theme.

Member Carman said she never called a park by its name. It was always by the color.

Member Wackerlin said maybe we could sacrifice one of the features for budget reasons, so we could add the features we want.

Member Sivakumar agreed.

The Board discussed adding some swings for wheel chair access.

Administrative Services Manager of Public Works Peter D'Agostino said we can certainly go back to the vendor and ask for these items. It will push the timeline back for the park. He also asked if the Board would be voting tonight.

Chairwoman Tredore said that they won't be voting. She said we know we want concept two, but there are changes to the design that they would like to see.

Administrative Services Manager of Public Works Peter D'Agostino thanked the Board.

Director of Parks and Recreation Trevor Bosack asked the Board just to be clear, staff direction is for some sort of theme, like the one in concept three and four. Replacing one of the swings with a swing that will lock in place for wheel chairs. He asked the Board if that captures what they wanted.

The Board responded yes.

Recreation Superintendent Kim Buscemi said that the Preschool Academy, which used to be upstairs, is now going to be used for the newly established Parks and Recreation Department. The preschool will now be in the downstairs location. She discussed the improvements that were made at the Annex Preschool. She offered to take the Board on a tour of the Annex. Member Wackerlin had Horner Park for August and thought it looked great. The only thing he saw that looked bad, were some bottles in the mulch.

Member Cairns had Indian Trail Beach for July. He said he really only has one complaint and that is the fence.

Superintendent of Public Properties Scott Parchutz said the fence is getting replaced.

Member Cairns said they should move the parking blocks away from the fence, because cars pull up to them and hit the fence.

Member Cairns had Ken Carpenter Park for the month of August. He thought it looked good. Chairwoman Tredore had Ford School Park in August. She said it was quite busy. She said one of the parents commented on how much they love the park. The only thing she noticed was that there was a lot of weeds. A couple of the bricks in the gazebo area were not even. She thought it was a tripping hazard. The mulch needs raking.

Vice-Chairman Andrea had Barbara Key Park for July, and couldn't recall what he thought, he will send a written report over. Vice-Chairman Andrea had Butch Hagele Beach in August and wanted to know if it is always locked when the beach is red flagged.

Superintendent of Public Properties Scott Parchutz said if the beach is flagged they do keep the gates locked. We don't want to risk anyone going into the lake.

Member Sivakumar had Jaycee Park for August and thought it needed some work. She said there was a lot of rust around the basketball courts and the zipline. She also noticed a lot of trash from the car wash and wondered if there is anything they can do for that.

Superintendent of Public Properties Scott Parchutz said that now they have people working on the weekend and the trash will be emptied.

Member Carman had Celebration Park. No one was there but the park looked great. It was the first park that she saw a bench in honor of someone. She thought the bushes needed some pruning.

Member Carman had Hynes park for the month of August. She did notice some graffiti, but other than that it looked great. She talked to a parent who expressed that there is not a lot for small children to play on.

Member Carman brought up water quality in McHenry County and there is going to be a presentation at the MCC College on August 31.

## EXECUTIVE SUMMARY

---

The Parks and Recreation Board met on August 4, 2022 to review four (4) proposed playground design concepts from two (2) playground equipment providers including Play Illinois and Parkreation/Hacienda Landscaping.

Staff presented the design concepts and provided background to the Parks and Recreation Board that the concepts provided to the Village from Parkreation/Hacienda Landscaping did not capture the desired outcomes with the Pour-In-Place (PIP) surfacing and, in adding PIP elements to their initial concepts, went over budget by \$27,660. Staff made a recommendation to the Parks and Recreation Board to recommend Concept #2 to the Village Board, as it received the second highest rating from both resident surveys, while including PIP paths and other inclusive features.

Based on the staff recommendation, and incorporating feedback from the resident surveys, the Parks and Recreation Board provided direction to staff to incorporate nature-based play structures / elements into Concept #2 that were identified from other presented concepts. The Parks and Recreation Board also requested staff to look into the possibility of including a wheelchair accessible swing into the playground design.

Regarding the wheelchair swing, Play Illinois indicated that this type of swing would remove four (4) of the proposed swings including two (2) of the belt seats, the ADA swing, and the Konnection seat.

Staff took the direction from the Board to request additional nature themed elements to Concept #2 as outlined below and as reflected in the attachments.

One other item of note; this playground replacement has been moved and budgeted appropriately for completion in 2023.

Staff recommends that the Parks and Recreation Board recommend design concept #2 to the Village Board incorporating the consensus nature elements, as requested by the Parks and Recreation Board.

### *LIMITATIONS*

The following chemicals may cause damage to the playground surface and should be avoided: disinfectants, concentrated chlorine bleach, gasoline, diesel fuel, hydraulic and lubricating oils, acids and organic solvents.

Though not commonly used in water play areas, pool surrounds and similar applications, dissolved minerals and other chemicals (hydrochlorides) may cause surface discoloration over time. This condition, should it occur, is not considered to be a product failure.

A yellowish shading of the top surface will be noticeable when using standard aromatic urethane binder (PPlay system-7 system) to encapsulate some colors of EPDM / TPV granules. This characteristic is industry-wide. An aliphatic urethane binder (MegaPlay-10 system), which does not produce this yellowish shading, is recommended. The specifier should seriously consider its use, especially with the following surface colors: blue, turquoise, purple, eggshell and grays. For indoor applications where variable exposure to UV (ultraviolet) light occurs through windows, use of the aliphatic binder is recommended to ensure acceptable long-term aesthetic and visual consistency. Aliphatic binder must be used for water play areas.

## **5. Installation**

### *PREPARATORY WORK*

*Store materials* protected from exposure to harmful environmental conditions and at a minimum temperature of 40 degrees F (4 degrees C) and a maximum temperature of 90 degrees F (32 degrees C).

*Install surfacing* system when minimum ambient temperature is 40 degrees F (1 degree C) and maximum ambient temperature is 90 degrees F (32 degrees C).

### *METHODS*

Do not proceed with playground surfacing installation until all applicable site work, including substrate preparation, fencing, playground equipment installation and other relevant work, has been completed. Substrate preparation must be in accordance with surfacing manufacturer's specification. New asphalt must be fully cured – up to 30 days. New concrete must be fully cured – up to 7 days.

### *SURFACE PREPARATION*

Using a brush or short nap roller, apply primer to the substrate perimeter and any adjacent vertical barriers such as playground equipment support legs, curbs or slabs that will contact the surfacing system at the rate of 300 ft<sup>2</sup>/gal (7.5 m<sup>2</sup>/L).

### *BASEMAT INSTALLATION*

Using screeds and hand trowels, install the basemat at a consistent density of 29 pounds, 10 ounces per cubic foot (475 kg/m<sup>3</sup>) to the specified thickness.

Allow basemat to cure for sufficient time so that indentations are not left in the basemat from applicator foot traffic or equipment. Do not allow foot traffic or use of the basemat surface until it is sufficiently cured.

### *PRIMER APPLICATION*

Using a brush or short nap roller, apply primer to the basemat perimeter and any adjacent vertical barriers such as playground equipment support legs, curbs or slabs that will contact the surfacing system at the rate of 300 ft<sup>2</sup>/gal (7.5 m<sup>2</sup>/L).

### *TOP COURSE INSTALLATION*

Using a hand trowel, install basemat at a consistent density of 58 pounds, 9 ounces per cubic foot (938 kg/m<sup>3</sup>) to a nominal thickness of 1/2" (12.7 mm). Allow top course to cure for a minimum of 48 hours. At the end of the minimum curing period, verify that the top course is sufficiently dry and firm to allow foot traffic and use without damage to the surface. Do not allow foot traffic or use of the surface until it is sufficiently cured. Complete installation recommendations are available from the manufacturer.

### *PRECAUTIONS*

Protect the installed playground surface from damage resulting from subsequent construction activity on the site.

## 8. Maintenance

### *OUTDOOR APPLICATIONS*

Using a standard leaf blower or broom, remove any light weight debris such as leaves, trash, etc. Using a watering hose or a pressure washer, not exceeding 1000 PSI, rinse off all excess debris from the surface. While surface is wet, apply a mild cleaning detergent and agitate lightly with a soft bristle brush. Repeat as necessary. Once clean, final rinse with low-pressure water from a hose to remove any excess-cleaning agents.

### *INDOOR APPLICATIONS*

Using a standard vacuum cleaner/shop vac, or broom, remove any light weight unwanted debris. Apply a mild cleaning detergent and agitate lightly with a soft bristle brush or mop. Repeat as necessary.
