VILLAGE ENTERS 2023 BUDGET SEASON

Beginning in late spring, the Village enters one of its most important projects: creating the next fiscal year's annual budget. The budget process lasts nearly six months and includes a Budget Workshop and a Budget Hearing.

All budget meetings are open to the public for input. This year's Budget Workshop is scheduled for Tuesday, November 15 at Village Hall. The Budget Hearing is scheduled for Tuesday, December 6 at Village Hall. Visit lith.org/events as the dates approach to find meeting times.

In preparation for the annual budget, each department takes a critical look at operations and justifies a need for each requested dollar. Staff works together to evaluate everything from office supplies, staffing levels, and the effectiveness of current processes and programs. Each department must consider capital assets, personnel requests, revenue projections, and operating expenses.

Departments begin by evaluating capital asset needs in late summer. The Village considers capital assets to be items with an estimated useful lifespan of one year or more, exceeding specific dollar amounts.

Together, we've been celebrating the 70th anniversary of the Village's incorporation, and we look forward to honoring the momentous milestone at the annual Summer Sunset Festival over Labor Day weekend. I can't wait to see you at Sunset Park between September 2-4 for the parade, live music, car show, craft fair and business expo, wine tent, carnival, Rec2U Kids'

So far, 2022 has been one of both celebration and success for the Village. I am pleased to share that in the biennial report issued by the Illinois Department of Insurance (IDOI), the Village's Police Pension Fund had an 82% funded ratio, which was the 10th best-funded Article 3 Police Pension Fund in the state based on the IDOI's actuarial methods and assumptions. Financial health is always at the forefront of our decision making, and we are pleased to know that this fund outperformed 97% of all Police Pension Funds in the biennial report. which included all other Police Pension Funds in McHenry County that ranked anywhere from 56th place to 321st place.

The Lake in the Hills Police Department looks forward to a new facility in the near future. The Village is pursuing the creation of a stand-alone police facility on the grounds of Village Hall at 600 Harvest Gate. At this time, construction is anticipated

to commence no later than 2025. The new building will replace the existing facility that is over thirty years old, provide adequate space and resources to support the department's operations, and allow for improved emergency response times due to the centralized location. ELECTION INFORMATION

Election Day is November 8, 2022. Early voting will be held in the Community Room at Village Hall, 600 Harvest Gate, on the following dates.

- Monday, October 24 to Saturday, October 29
- Monday, October 31 to Monday, November 7

All registered voters that live in McHenry County are eligible to vote at Village Hall during the early voting period. All ballot styles for Algonquin Township, Grafton Township, and Nunda Township will be available at all Early Voting Centers, and voters may choose to vote at the site most convenient for them.

POLICE PENSION FUNDING UPDATE

As of the most recent biennial report issued by the Illinois Department of Insurance (IDOI) based on 2020 financial data, the Lake in the Hills Police Pension Fund had an 82% funded ratio, which was the 10th bestfunded Article 3 Police Pension Fund in the state based on IDOI's actuarial methods and assumptions.

The IDOI biennial report contained 351 separate downstate police pension plans with an average funded ratio of only 56%, which makes achieving an 82% funded ratio a significant accomplishment that outperformed 97% of all Police Pension Funds in the biennial report, including all other Police Pension Funds in McHenry County that ranked anywhere from 56th place to 321st place.

AIRPORT TOURS

The Lake in the Hills 3CK Airport offers free tours for school groups and non-profit organizations. PRACTICE FIRE SAFETY AT HOME

According to the U.S. Department of Homeland Security, a fire can become life-threatening in two minutes and engulf a residence in five minutes. Protect your family and your home by following fire safety practices.

SMOKE ALARM TIPS

- Ensure that your home's smoke alarms are functioning properly and installed on each level of your home, including the basement.
- Unless your smoke alarms utilize 10year lithium batteries, replace the batteries twice per year.

- Replace all smoke alarms every 10 years or according to the manufacturer's instructions.
- Never disable a smoke alarm while cooking.
- Audible alarms are available for those who are visually impaired, and smoke alarms with a vibrating pad or flashing lights are available for those who are hearing impaired.

CREATE A FIRE ESCAPE PLAN

- Create a fire escape plan and practice it at least twice per year.
- Practice navigating to your home's exit by feeling your way out of the house in the dark or with your eyes closed to simulate smoke.

- Locate two exits per room to prepare to escape in the event that the primary exit is blocked.
- Make sure that windows are not stuck, screens can be taken out quickly, and security bars can be properly opened.
- Teach your children not to hide from firefighters and educate them about the critical role they play.
- If you or a member of your household uses a walker or wheelchair, check all exits to be sure you or the individual can get through the doorways.

REAL ESTATE TAX BILL INFORMATION

The Village's largest revenue source is the property tax. Property taxes are used to pay for employer pension contributions, payroll taxes, liability and workers' compensation insurance coverages, and portions of general operating and public safety costs. Last year, on behalf of our residents and businesses, the Village kept its portion of the total property tax levy flat or decreased for the 12th consecutive year.

However, in 2021, there was a change made from prior years' levies that was reflected on the tax bills payable in 2022. All components of the levy, except for the Corporate Levy, were shifted to a placeholder amount of \$1,000 by levying the majority in the Corporate Levy. This method provides the Village with the greatest flexibility in how these funds can be spent, since the Corporate Levy can be spent on any lawful purpose. The restricted levies for IMRF, Police Protection, Police Pension, Audit, Liability Insurance, Social Security, and Workers' Compensation can only be spent on each of those specific purposes. This results in no impact to the dollar amount, but eases restrictions on how tax levy proceeds can be utilized.

Here's an example of how this is reflected using an actual real estate tax bill. Notice how the Village pension tax last year was \$332.84; while this year, the pension tax is \$0.36. This is because those funds were shifted to the Corporate Levy, which now totals \$660.00. (Note: amounts will vary based on address.)

The Village's 2021 levy accounted for 8% of the average property tax bill, while school districts made up 64%, and McHenry County made up 8%. The remaining 19% classified as "Other" is comprised of townships, fire protections districts, park districts, library districts, the Lake in the Hills Sanitary District, and the McHenry County Conservation District. It is notable that these percentages did not change from 2020.

These are often "big ticket" items and can include improvements to buildings, playgrounds, vehicles, software, equipment, roadway improvements, and more.

Once capital requests, personnel costs, and revenue projections are reviewed, the departments present their operating budgets to the Village Administrator, Assistant Village Administrator, and Finance Director. Meetings are held throughout the process to review each departmental budget in line-by-line detail.

Adjustments, cuts, notes, and revisions are made until a balanced budget proposal is compiled. It is posted to the Village website for the public to access and distributed to the Village Board for review in advance of the Budget Workshop.

During the Budget Workshop, staff reviews the proposed budget with the Village Board. The Village Board and the public may ask questions, make suggestions, and request changes.

After the Budget Workshop, staff uses the next month to finalize any changes that result from the Budget Workshop before the Budget Hearing a month later. At the hearing, the public has an opportunity to share comments, and the Village Board votes whether or not to pass the budget at the following board meeting.

Residents are invited to review the proposed budget at lith.org when it becomes available in November. You will also find Popular Annual Financial Reports, which provide a simplified look at the Village's finances, for previous fiscal years.

The Budget Workshop and Budget Hearing are both public meetings, and all are welcome to attend.

Fall & Winter Seasonal Reminders

STORM DRAINAGE SYSTEM

Storm grates direct stormwater from the street into the underground pipe system. Sometimes in the fall, leaves cover grates and cause localized flooding and pedestrian, bicycle, and motor vehicle accidents. Rotting leaves also diminish the life span of the asphalt underneath them, leading to premature repair needs.

In areas that do not have a curb and gutter, the swale in front of your home (the "ditch" that runs across the front of your property) is designed to hold stormwater when it can no longer soak into the ground to maintain a dry roadbed, filter runoff, and reduce pollutants. It is critical that you continue regular swale maintenance to minimize flooding.

So, what can you do?

- Check storm drain grates frequently to make sure they are free of leaves and debris.
- Use a rake or pitchfork to clear leaves and debris from grates so that water can drain easily.
- Do not rake leaves into swales as this will cause a blockage for water flow.
- Mow and maintain your swale at an acceptable grass height. Tall grass slows water movement.
- Blow grass clippings back onto grass or landscape areas.
- Keep your driveway culvert open.
- Remove leaves from swales to stop them from flowing downstream, clogging up culverts, and possibly creating flooding issues.
- Do not remove the grate from the storm drain opening.
 This does not unclog the system and creates a hazard.
- Rake leaves away from storm drains.
- Do not rake or blow leaves from your property into the street.
- Dispose of leaves in a yard waste container or compost bin.

SNOW REMOVAL REMINDERS

When snow begins to fall or icy conditions are present, the Public Works Department is ready to set snow and ice removal operations into motion to clear the streets and help you get on your way as quickly and safely as possible. Remember:

- Children need to stay clear of snowplows.
- When driving, stay back at least 100 feet from moving plows and do not pass moving plows.
- Before children build snow forts, remind them to stay on private property and never build forts on the parkway next to streets, which can be dangerous.
- After a snowfall, clear sidewalks of snow and ice for the safety of pedestrians. Snow-covered sidewalks impede access for emergency, fire, and home health services.
- Remove items from the parkway that overhang the curb, especially portable basketball hoops.
- When clearing snow from your driveway, shovel snow in the direction of traffic and in the direction of plowing operations onto the parkway.
- Please refrain from blowing or throwing snow into the street. This action can create a hazardous condition.
- Do not put snow removed from driveways near fire hydrants, and help keep areas around fire hydrants clear.
- Do not park on the street when snowfall is predicted. After one inch of snow accumulates, parking is prohibited and violators may be ticketed.
- Remove garbage cans from the curb when snowfall is predicted or when snowfall occurs. Garbage cans create unnecessary hazards for snowplow drivers and prevent the efficient removal of snow.

Crews clear the main streets first to speed response time for emergency vehicles and then move to secondary and residential streets. Please call Public Works at 847-960-7500 with any questions about the snowplowing program. If Village equipment has damaged the parkway area in front of your home, report it to Public Works as soon as possible at 847-960-7500. Repairs will be conducted in the spring.

YARD WASTE

Flood Brothers Disposal picks up landscape waste on your normal waste collection day from the first full week in April through the last full week of November. This includes grass, leaves, and branches less than 4" in diameter.

Landscape waste must be contained in either a 30-gallon biodegradable paper bag or a standard 35-gallon metal or plastic garbage container identified as "Yard Waste Only" that weighs less than 60 lbs. "Yard Waste Only" stickers are available free of charge at Village Hall, 600 Harvest Gate, or the Public Works Facility, 9010 Haligus Road.

Landscape waste, including brush and other branches four inches or less in diameter that are too bulky for placement into paper bags or cans may be securely tied with biodegradable string or twine in bundles not exceeding four feet in length and 60 pounds in weight.

FLOODWAY AND FLOODPLAIN INFORMATION

Residents may view information and maps that show the designated floodway and floodplain areas within Lake in the Hills, along with elevation certificates dating back to 2000.

Any construction within these areas requires review by our staff prior to the start of any project. Additional permits from other agencies may be required in addition to Village-issued permits. Homeowners within this area may be required to maintain flood insurance.

ELECTRONICS RECYCLING

Flood Brothers Disposal, the Village's solid waste services provider, offers electronic waste recycling services to all Lake in the Hills residents at no additional cost. Electronic waste can be placed at the curb on the third week of every other month. Residents must call Flood Brothers at 630-261-0578 to confirm that their items are eligible for recycling and schedule a curbside pickup on their regularly scheduled pickup day. Electronics may be recycled during the following weeks:

- The week of October 17, 2022
- The week of December 19, 2022
- The week of February 20, 2023
- The week of April 17, 2023



WOODS CREEK REACH 11 RESTORATION

Woods Creek will receive restoration improvements this year. The intent of the Woods Creek Reach 11 Restoration Project is to stabilize 5.226 linear feet of streambank and restore adjacent wetlands to native conditions. Reach 11 is located behind the residences along Starwood Pass, Polaris Drive, and Harvest Gate.

The project started in August 2022 with conclusion of earthwork and creek improvements expected by December 31, 2022. Full project completion is scheduled for May 31, 2023 with final

seeding and plant installation. The scope of work will include the removal of non-native vegetation, streambank restoration and stabilization, tree removal, and seeding of native vegetation. Find up-to-date project information at lith.org/Reach11.
