Two Arrests Made in Execution of Search Warrant

Lake in the Hills, IL – On Friday, April 14, 2023, at approximately 1:45 p.m., the Lake in the Hills Police Department, along with the McHenry County Sheriff's Office Multijurisdictional SWAT Team, executed a search warrant in the 0 block of Deerpath Rd. The search warrant was the result of an investigation into illegal activity. Two subjects were taken into custody without incident; Jordan M. Aristud and Alberto I. Pietri-Molina.
