### **Lake in the Hills Police Department Announces Results of Alcohol Compliance Checks**

**Lake in the Hills, IL** – On November 20, 2019, with assistance from the Algonquin Police Department, the Lake in the Hills Police Department conducted compliance checks of liquor establishments within the Village of Lake in the Hills. The operation involved sending minors into area liquor establishments in an attempt to purchase alcohol. A total of 30 retailers were inspected; 27 were found to be compliant. Three (3) businesses were in violation after selling alcohol to a person less than 21 years of age and were issued ordinance tickets as a result.

The alcohol compliance checks are one part of the process the Department uses to reduce the illegal sale of alcohol to persons under the legal drinking age. The Lake in the Hills Police Department offers the Beverage Alcohol Sellers and Servers Education and Training (BASSET) program as a proactive step in reducing illegal consumption by minors.
