COMMUNITY PROFILE

FISCAL YEAR 2024 ANNUAL BUDGET

Lake in the Hills is a scenic mix of business, recreation, and retail resources occupying 10.3 square miles in northeastern Illinois, McHenry County. The Village employs a home-rule, President-Trustee form of government, with six elected-at-large trustees. Municipal zoning is in effect and the Village has its own Planning and Zoning Commission. The latest Comprehensive Plan was published in 2002.






