#### **STAFF REPORTS**

#### **Recreation Staff Report:**

Director Mullard reported that the Recreation staff has been working hard to adapt as it relates to the operational changes brought on by the COVID-19 pandemic. Preschool ended for the year; races were cancelled and most of the June programming was cancelled. Director Mullard reported that they are looking into what a virtual camp would look like (to be held in July) with the hope that they will soon be able to hold an in-person camp. The summer brochure is being re-worked and will be sent out to everyone in the Village.

#### PARKS STAFF REPORT

Superintendent Parchutz reported that staff is meeting with the contractor awarded the 1109 Pyott Road and 9017 Haligus demolition projects and they plan to begin work in the next week or two. Public Properties staff will be replacing the existing Thorgard weather prediction system this year. Superintendent Parchutz mentioned that the Indian Trail Beach roof replacement project was completed, the Bark Park fence replacement project is expected to start soon, the Hain House heating and air conditioning will be replaced using in-house staff this year. Additionally, staff is currently removing all the weedy sandbar willows from Sunset Park.

#### TRUSTEE LIAISON REPORT

Trustee Murphy had no report. Chairwoman Tredore asked about the status of Sunset Festival. Trustee Murphy reported that the Sunset Festival is on hold for right now.

**SUBJECT:** Community Recreation Survey

#### **EXECUTIVE SUMMARY**

The Parks & Recreation Division recently put forth a survey to gain a better understanding of how the community feels about organized events and activities for the summer. The survey was open to the public from May 14 through June 1. The survey link was sent to customers via Community Pass, was posted on the Village website, social media channels, Resident Insider newsletter and marquee signs. We received 285 responses.

From the data received, it is clear that the community would prefer in-person activities over virtual. There may be an opportunity to reach some participants through virtual early childhood or cultural arts programs; however, it would need to be free or very low cost. When planning for in-person activities, we will need to look at areas like nature, which received the largest interest from the programming groups offered. This could be due to the current COVID recommendations and that they may feel safer in programs that are run outdoors. Families will be cautious and particular about what they choose to participate in this summer. There is a definite call for caution and the need for clear and absolute procedures for safety, cleaning, and group control.



### **Recreation Project Status**

The Summer brochure was delivered to Residents and is available on the Village's website. Registration is slow, as expected. Staff is working on strategies to connect with past participants to encourage registration. Programs and classes are starting and striving to build as we move through Phase 3 and closer to Phase 4.

Fall brochure planning is also beginning to stay on track with an August brochure delivery date.

### A. Contractor Updates:

- Hot Shots Sports will be holding in person classes with social distancing recommendations starting in July. This will be based on the most up to date recommendations and restrictions put forward by the State of IL and the CDC.
- Sports R Us will be holding in person classes with social distancing recommendations starting in July. This will be based on the most up to date recommendations and restrictions put forward by the State of IL and the CDC.
- Yoga classes have been moved to Village Hall for June so they can space 10 feet apart in the area outside the community room per the Phase 3 guidelines.

#### **B.** Events/Trips:

- Senior trips and events have been cancelled for the summer however we have our first GoTo Meeting "Coffee Chat", Wednesday, June 3rd at 9 am. We have three seniors interested in trying the video chat. If this goes well, we will try other activities and hopefully get more participants.
- Virtual event opportunities are being explored with the use of the virtual camp platform. Staff will discuss and utilize the community survey results as a guideline.

### C. Programs:

• Preschool staff is working on plans for summer camp running in July and preparation for the 2020-2021 school year is in the works. This will be based on the most up to date recommendations and restrictions put forward by the State of IL and the CDC.

### D. FuntastiCAMP:

• Virtual camp began June 8. Although only seven participants are currently enrolled, they are excited by the opportunity to socialize and be creative in a new way. A box of supplies needed for the next week's program is sent out every Friday. Camp is online for four hours

- of the eight-hour camp day. Staff is encouraging the current participants to spread the word about the program in an attempt to increase enrollment.
