Lake in the Hills, IL - The Village of Lake in the Hills is excited to announce that for the 20th consecutive year, it has received the Government Finance Officers Association (GFOA) Distinguished Budget Presentation Award for the Fiscal Year beginning January 1, 2019.

In March of 2019, the Village submitted its annual budget for the Fiscal Year beginning January 1, 2019, to GFOA to be reviewed and judged by an impartial panel. To receive the GFOA Award, Lake in the Hills satisfied nationally recognized guidelines and high standards for effective budget presentations. The guidelines assess how well a budget document frames financial information within the context of an organization's overall operations. GFOA requires that budget presentations serve as a policy document, a financial plan, an operations guide and a communications device. To receive the award, budget documents must be rated "proficient" in all four categories and the fourteen mandatory criteria within those categories.

This 20-year achievement demonstrates the dedication and professionalism of a wide variety of individuals throughout the organization who ensure the annual budget presentation meets GFOA's rigorous high standards. Lake in the Hills has obtained the most Distinguished Budget Awards in McHenry County as a result of these collective efforts.

"The annual budget process is a true collaborative effort that thrives on valuable input from residents and businesses, strategic direction and support from the Village Board and the time, energy and competence of staff in order to produce such a high-quality document. To receive this award for the 20<sup>th</sup> year is a testament to the dedication and pride of our Village Board and staff, as well as all the previous Village Boards and staff members over the years, who helped make this achievement possible," said Assistant Village Administrator/Finance Director Shane Johnson.
